### Instructions

- Within **one year** of the issuance of a Chenango County Pistol Permit the permit holder must complete a safety course **from this list**. Upon course completion, **bring the original completion certificate and permit** to the County Clerk's Office. A duplicate permit with the expiration date removed will be issued.
- If the permit holder would like to **remove the hunting and targeting shooting restriction** they must complete one of the advanced courses listed under **Carry Concealed Courses**. Taking a Carry Conceal Course will **also** count towards the remove of the permits **expiration date**. A **\$5 fee** is required to issue a duplicate permit with the hunting and targeting shooting restriction removed. The Chenango County Clerk's Office accepts **cash or checks only**.
