LOCAL LAW NO. 1 OF 1979

A Local Law fixing the annual salaries of certain County Officers.

Be It Enacted by the Board of Supervisors of the County of Chenango

Section 1. The flat annual salaries of the following named County Officers shall be the amount set opposite each, to wit:

Commissioner of Social Services	\$25,800.00
County Highway Superintendent	19,300.00
Director, Real Property Tax Services	17,900.00
County Treasurer	17,300.00
Commissioners of Elections (2)---each	11,300.00

Section 2. The above specified salaries shall be effective on and after January second, nineteen hundred and seventy-nine.

Section 3. This law shall be subject to a permissive referendum as provided in Section 24 of the Municipal Home Rule Law of the State of New York, but no petition for a referendum be filed, then this law shall become effective upon filing same with the Department of State and State Comptroller's Office.

Seconded by Mr. Angell and duly adopted.
