SECTION 1: Section 8 of the Plan is hereby amended by adding a sentence after the third sentence in said Section 8 to read as follows:

"Where participating towns contain incorporated villages which are also participants, the village share shall be levied by the County Treasurer and billed to the towns containing said villages as a county general charge with the towns general assessment as a charge-back and the participating villages shall not be billed separately."

SECTION 2: This local law shall be effective immediately.

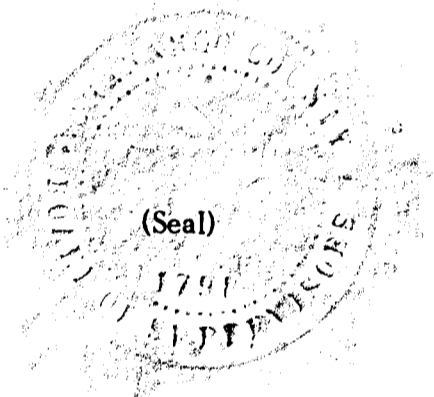
