Local Law No. 2, Year 1988

A LOCAL LAW DELEGATING TO THE CHAIRMAN OF THE BOARD OF SUPERVISORS OF THE COUNTY OF CHENANGO THE POWER TO AUTHORIZE THE ATTENDANCE OF ANY OFFICER OR EMPLOYEE, PAID FROM COUNTY FUNDS, AT CONVENTIONS, CONFERENCES AND SCHOOLS, CONDUCTED FOR THE BETTERMENT OF MUNICIPAL GOVERNMENT, PURSUANT TO THE PROVISIONS OF SECTION 77-b OF THE GENERAL MUNICIPAL LAW.

Be it enacted by the Board of Supervisors of the County of Chenango, as follows:

There is hereby delegated to the Chairman of the Board of Supervisors of this County the power to authorize the attendance, at County Expense, of any County Officer or employee at conventions, conferences and schools conducted for the betterment of municipal government, if believed to be of benefit to the County or any department thereof.

This Local Law shall become effective on and after the first day of January, nineteen hundred and eighty-nine.

The Chairman declared the Local Law adopted.

5. (City local law concerning Charter revision proposed by petition.)
