A LOCAL LAW FIXING ANNUAL SALARIES OF CERTAIN COUNTY OFFICERS

BE IT ENACTED, by the Board of Supervisors of Chenango County

Section 1. That flat annual salaries of the following named County Officers shall be in the amount set opposite each, to wit:

Commissioner of Social Services	\$46,400.00
County Superintendent of Highways	40,550.00
Director of Real Property Tax Services	31,750.00
County Attorney	29,950.00
Personnel Officer	26,500.00
Commissioner of Elections (2) each	12,100.00
Clerk of the Board/County Auditor	28,500.00

Section 2. The above specified salaries shall be effective on and after January second Nineteen hundred and Eighty-nine.

Section 3. This law shall be subject to permissive referendum as provided in Section 24 of the Municipal Home Rule Law of the State of New York, but if no petition for a referendum be filed, then this law shall become effective upon filing same with the Department of State and the State Comptroller's Office.
