Section 1. DECLARATION OF FINDINGS AND INTENT.

The Chenango County Board of Supervisors hereby finds:

(a) That a certain portion of County Real Property at the Lt. Warren E. Eaton Chenango County Airport located in the Town of North Norwich, County of Chenango, is not necessary for airport operations;

(b) That the transfer of title of such certain portion of real property to the County of Chenango Industrial Development Agency for purposes of development of an industrial park would serve the public interests of the County by promoting its economic development, attracting the establishment and location of commercial and industrial enterprises within the County of Chenango and otherwise benefiting the citizenry of the County.

Section 2. AUTHORIZATION OF TRANSFER.

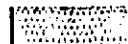
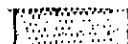
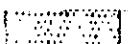
Notwithstanding the provisions of Section 215(4)(5) and (6) of the County Law, the Chenango County Board of Supervisors may by resolution authorize the transfer and conveyance by deed of all the rights, title and interests of the County of Chenango in that certain portion of property at the Lt. Warren E. Eaton Chenango County Airport not necessary for airport operations to the County of Chenango Industrial Development Agency upon such terms and conditions as may be prescribed by the Board of Supervisors. Such transfer and conveyance may be made without consideration.

Section 3. SUBJECT PROPERTY; CONDITIONS.

(a) The property subject to this local law is approximately thirty-four (34) acres more or less located at the Lt. Warren E. Eaton Chenango County Airport in the Town of North Norwich, County of Chenango, State of New York.

(b) The transfer and conveyance authorized by this local law shall not be completed until such time as the Federal Aviation Administration (FAA) and the New York State Department of Transportation (DOT) have indicated their respective consent or acquiescence in such a transfer.

Section 4. EFFECTIVE DATE.

Pursuant to Section 24 of the Municipal Home Rule Law of the State of New York, this local law shall take effect forty-five (45) days after it shall have been adopted unless a proper Petition has been filed so as to require a permissive referendum in which case this law shall take effect upon its approval by a majority of qualified electors at an election called in accordance with the provisions of said statute.
