A LOCAL LAW TO AMEND THE CHENANGO COUNTY
SELF-INSURANCE PLAN

BE IT ENACTED by the Chenango County Board of Supervisors as follows:

SECTION 1. Local Law No. 1 of 1956, as amended by Local Law No. 2 of 1959, as amended by Local Law No. 4 of 1978, as amended by Local Laws Nos. 2 and 3 of 1982, is hereby amended by replacing the Self-Insurance Plan Reserve Fund figure of \$500,000.00 set forth in Section 11-a with the figure of \$1,000,000.00.

SECTION 2. This Local Law shall be effective immediately.
