BE IT ENACTED, BY THE Board of Supervisors of Chenango County.

Section 1. The flat annual salaries of the following named County officers shall be in the amount set opposite each, to wit:

Section 2. The above specified salaries shall be effective on and after January One, Nineteen Hundred and Ninety Two.

Section 3. This law shall be subject to a permissive referendum as provided in Section 24 of the Municipal Home Rule Law of the State of New York, but if no petition for a referendum be filed, this this law shall become effective upon filing same with the Department of State and the State Comptroller's Office.

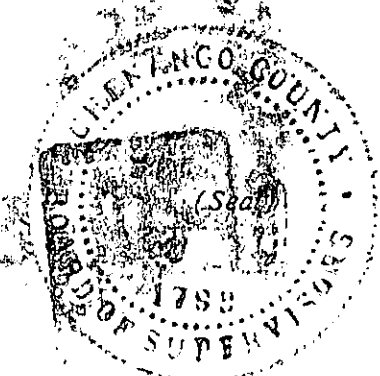
