LOCAL LAW NO. 1 OF THE YEAR 1993

"A COUNTY LOCAL LAW AUTHORIZING THE SALE OF A CERTAIN PARCEL OF SURPLUS COUNTY REAL PROPERTY IN THE TOWN OF NORWICH TO SHELBORN PROPERTIES, INC."

BE IT ENACTED by the Chenango County Board of Supervisors as follows:

Section 1. DECLARATION OF FINDINGS AND INTENT.

The Chenango County Board of Supervisors hereby finds:

- (a) That a certain piece of County real property in the Town of Norwich is not necessary for public purposes and by duly enacted Resolution, has been declared surplus by the Board; and
- (b) That the granting of an option and the possible sale and transfer of said certain parcel of real property to Shelborn Properties, Inc. its successor or assigns, for commercial development will serve the public interests of the County by facilitating economic development, including but not limited to job creation; infusion of moneys into the local economy; providing local retail establishments readily accessible to County resident; and adding to the tax base of the County and similar general benefits to the citizenry of the County.
- Section 2. AUTHORIZATION OF TRANSFER.
- (a) Notwithstanding the provisions of County Law, Section 215 and specifically subdivision 6 thereof, the Chenango County Board of Supervisors hereby authorizes the private sale and transfer of title of a certain piece of surplus County real property in the Town of Norwich to Shelborn Properties, Inc., its successors or assigns. Said authorization includes the granting of an exclusive option to

purchase said property. Said option may be for an initial term of one year from the date of execution and may be renewable for an additional year.

- (b) The following general provisions shall, in substance, be provided for in any option or other agreement entered into between the County and Shelborn Properties, Inc.:
- i. The Consideration for the initial one year option shall be at least One Dollar, with any extension beyond one year commanding consideration of at least Five Hundred Dollars per month;
- ii. If the option is exercised, consideration for the property shall be at least Fifty Thousand Six Hundred Fifty-Five Dollars (\$50,655.00) representing Five Thousand Five Hundred Dollars per acre subject, however, to appropriate adjustments as may be provided in the option agreement negotiated and entered into between the County and Shelborn Properties, Inc.
- (c) This Board of Supervisors, subject to the provisions hereof, shall have authority by Resolution of the Board to enter into an option or other appropriate agreement, and to convey title to the property to Shelborn Properties, Inc. its successors or assigns, on such terms as it may deem proper; and to authorize the Chairman of this Board to execute appropriate option agreements, contracts and deeds and to take such other action as may be necessary to effectuate the provisions of this local law.

## Section 3. SUBJECT PROPERTY.

(a) The certain parcel of real property which is the subject of this local law is approximately 10 acres more or less; is part of a larger parcel transferred to the County by deed dated June 11, 1991 and recorded in Liber 752 of Deeds at page 95 in the Chenango County Clerk's Office on June 17, 1991. The portion which is the subject hereof is generally described as follows:

All That Tract or Parcel of Land situate in the Town of Norwich, County of Chenango, State of New York, bounded and described as follows: Beginning at a point on the westerly side of N.Y.S. Route 12, which point is also the southeast corner of premises of Norwich Cemetery Association; thence running in a southerly direction and parallel to N.Y.S. Route 12, 55 feet, more or less, to a point, which point is also the northeast corner of a parcel of land excepted and reserved in a corrective deed from Robert Castle a/k/a Robert J. Castle and Gerald Levin to The Greater Norwich Foundation, and identified as Parcel 2 under said exceptions and reservations, dated September 8, 1989 and recorded in the Chenango County Clerk's Office September 19, 1989 in Liber 733 of Deeds at Page 250; thence running in a westerly direction along the northerly line of said Castle & Levin, and also along the northerly line of property now or formerly of Addison Swingle, a total of 390 feet, more or less, to a point; from thence running in a general southerly direction and along the westerly boundary of said Swingle, 258.73 feet, more or less, to a point in the southerly boundary of premises hereby conveyed where it intersects with the southwesterly corner of Addison Swingle at a point in the northerly boundary of other premises reserved in said corrective deed from Robert Castle a/k/a Robert J. Castle and Gerald Leven to The Greater Norwich Foundation dated September 8, 1989, identified as Parcel 1 under said exceptions and reservations; thence in a general westerly direction along the northern boundary of premises now or formerly of Robert Castle and Gerald Levin also reserved in said corrective deed dated September 8, 1989 from Robert Castle a/k/a Robert J. Castle and Gerald Levin to Greater Norwich Foundation and identified as Parcel No. 3 under said exceptions and reservations, 808 feet, more or less, to a point which is the southeast corner of the premises hereby conveyed; thence running in a general northerly direction and through the

premises of the County of Chenango 1179.04 feet, more or less, to a point which intersects with a southern boundary of Norwich Cemetery Association; thence in a general southerly direction and along a western boundary of Norwich Cemetery Association 741.07 feet to a point, and continuing along the boundary of Norwich Cemetery Association the following courses and distances: Generally Easterly 697.21 feet, more or less, to a point; Generally Southeasterly 39.05 feet, more or less, to a point; Generally EAsterly 236.21 feet, more or less, to the point and place of beginning; containing 10 acres of land, be the same more or less.

Being a portion of the premises conveyed by The Greater Norwich Foundation to the County of Chenango by deed dated June 11, 1991 and recorded in the Chenango County Clerk's Office June 17, 1991 in Liber 752 of Deeds at Page 95.

Subject to the rights of the public in and to the use of New York State Route 12; and

Subject to utility easements and rights of way of record.

(b) The above description may be altered to conform to the state of affairs a professional land survey would determine appropriate and any such surveyed description may be used for the purposes of conveyance or other transactions by the County with regard to said property

Section 4. EFFECTIVE DATE.

Pursuant to Section 24 of the Municipal Home Rule Law of the State of New York, this local law shall take effect forty-five (45) days after it shall have been adopted unless a proper Petition has been filed so as to require a permissive referendum, in which case this law shall take effect upon its approval by a majority of qualified electors at an election called in accordance with the provisions of said statute.
