ADOPTED LOCAL LAW NO. 6 OF 1995

A LOCAL LAW REPEALING CHENANGO COUNTY LOCAL LAW NO. 3 OF 1977

Be it enacted by the Board of Supervisors of the County of Chenango as follows:

1. Chenango County Local Law No. 3 of 1977 adopted pursuant to the New York State Environmental Conservation Law be and the same hereby is repealed and rescinded.
2. Hereafter the regulations set forth in Title 6 New York Code of Rules and Regulations, Part 617 and the State Environmental Quality Review Act (SEQRA) as set forth in the Environment Conservation Law, and any amendments to such regulations and statutes, shall provide the substantive and procedural requirements governing implementation of the State Environmental Quality Review Act (SEQRA) for the County of Chenango.
3. This Local Law shall take effect immediately subject to filing requirements of the Municipal Home Rule Law.

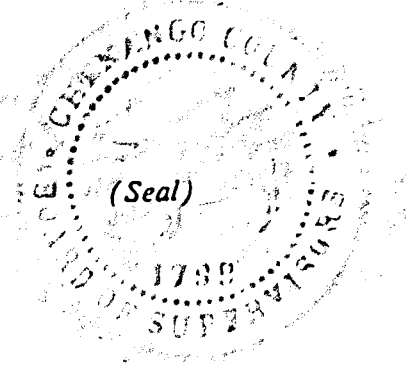
