LOCAL LAW

The Transportation Committee offered the following, proposed for enactment:

STATE OF NEW YORK COUNTY OF CHENANGO ADOPTED LOCAL LAW NO. 2 OF 1997

A LOCAL LAW RESTRICTING PARKING ON CERTAIN HIGHWAYS AND ROADWAYS WITHIN THE COUNTY OF CHENANGO

BE IT ENACTED by the Chenango County Board of Supervisors of the County of Chenango as follows:

Section 1. Purpose: This local law is to exercise the authority granted by Municipal Home Rule Law, Section 10; Section 215 of the County Law, and other applicable law to restrict parking as set forth herein so as to provide for the safety and welfare of the public.

Section 2. Definitions: (a) Unless otherwise provided, all terms shall have the meaning provided by the Vehicle and Traffic Law of the State of New York and Highway Law of the State of New York.

(b) For the purpose of this law "park" or "parking" means the standing of a vehicle, whether occupied or not, otherwise than temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers.

Section 3. Prohibited Acts: During the period of November 1st of each calendar year through April 15th of the next succeeding calendar year no person, persons, corporation, business, partnership, company or other entity shall park or suffer the parking of a motor vehicle on Chenango County highways, roadways, shoulders, or rights of way from the hours of 11:00 PM through 7:00 AM.

This restriction shall apply not only to the operator or driver of the vehicle but such vehicle's owner and/or lessee.

Section 4. Affected Highways or Roadways:

- a) This local law applies to all highways, roadways, shoulders or rights of way under the control of the County of Chenango, except those roads or portions thereof located within the boundaries of any Village or the City of Norwich.
- b) In no event shall a highway or roadway under the control of the New York State Department of Transportation be subject to this local law.
- c) In the event a Town has in effect parking regulations more restrictive than those of the County, such Town regulations shall take precedence.
- Section 5. Enforcement: This local law may be enforced by any police officer, peace officer acting within the scope of his or her duties, the County Highway Superintendent or designee(s) and any other Chenango County officials or employees designated to enforce the same by Resolution of the Chenango County Board of Supervisors. All such persons are authorized to issue an appearance ticket in accord with the Criminal Procedure Law and to take such other lawful actions as are necessary to enforce this local law.

Section 6. Penalties:

- a) <u>Criminal</u>: The violation of this local law shall be deemed a violation under the Criminal Procedure Law and punishable by a fine not exceeding two hundred and fifty dollars (\$250.00) or by imprisonment not exceeding fifteen (15) days, or by both such fine and imprisonment.
- b) <u>Civil</u>: In lieu of Criminal Penalties above, this local law shall be enforced by imposing a penalty of not more than two hundred fifty dollars (\$250.00) for any one violation, to be recovered in a civil action in any court having jurisdiction thereof, which action shall be brought in the name of the County.
 - c) Separate Offense: Each calendar day of violation shall be considered a separate violation.
- d) Additional Remedies: The County of Chenango or its officials may maintain an action or proceeding in any court of competent jurisdiction to compel compliance with or prohibit any violation of the provision of this local law including injunction, or any other proper legal remedy.
- Section 7. Separability: This local law is separate and apart from any other local law and each provision hereof is separate from any other provision. If this law or portion thereof is found to be invalid, no other law or unaffected portion of this law shall be affected thereby and shall remain in full force and effect.

Section 8. Effective Date: This law shall take effect immediately upon proper filing pursuant to law.
