BE IT ENACTED, by the Board of Supervisors of Chenango County.

Section 1. The flat annual salaries of the following named County Officers shall be in the amount set opposite each, to wit:

Commissioner of Social Services	\$55,106.00
Director of Public Works	\$65,454.00
Personnel Officer	\$43,312.00
Commissioner of Elections (2) each	\$19,133.00
County Sheriff	\$54,711.00
District Attorney	\$55,248.00
County Treasurer	\$51,092.00
