BE IT ENACTED, by the Board of Supervisors of Chenango County

Section 1. The flat annual salaries of the following named County Officers shall be in
the amount set opposite each, to wit:

Commissioner of Social Services	\$ 53,234.00
Director of Public Works	\$ 70,332.00
Personnel Officer	\$ 46,276.00
Commissioner of Elections (2) each	\$ 20,298.00
County Clerk	\$ 47,028.00
County Treasurer	\$ 54,370.00

Section 2. The above specified salaries shall be effective on and after January first, Two Thousand and Four.

Section 3. This law shall be subject to a permissive referendum as provided in Section 24 of the Municipal Home Rule Law of the State of New York, but if no petition for a referendum be filed, then this law shall become effective upon filing same with the Department of State.

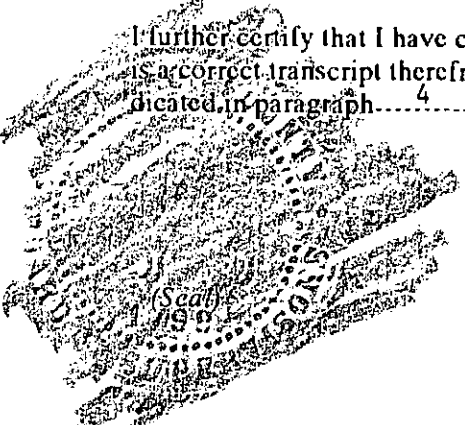
