A LOCAL LAW FIXING ANNUAL SALARIES OF CERTAIN COUNTY OFFICERS FOR THE YEAR 2011

BE IT ENACTED, by the Board of Supervisors of Chenango County.

Section 1. The flat annual salaries of the following named County Officers shall be in the amount set opposite each, to wit:

Commissioner of Social Services	\$ 68,620.00
Director of Public Works	\$ 85,208.00
Personnel Officer	\$ 56,755.00
Commissioner of Elections (2) each	\$ 30,402.00
County Sheriff	\$ 73,107.00
Clerk of the Board	\$ 61,893.00

County Attorney	\$	104,990.00
County Clerk	\$	57,651.00
District Attorney	\$	119,800.00
Public Defender	\$	56,927.00

Section 2. The above specified salaries shall be effective on and after January first, Two Thousand and Eleven.

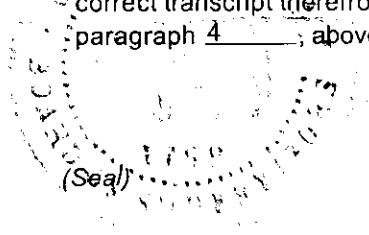
