Approved Chenango County Pistol Permit Safety Courses

Instructions

- Chenango County Pistol Permit holders must complete a safety course **from this list** to remove their permit expiration date. Upon course completion, **bring the original completion certificate** and permit to the Chenango County Clerk's Office.
- To remove the **hunting and targeting shooting restriction** permit holders must complete one of the courses listed under **Carry Concealed Courses**. Taking a Carry Concealed Course will also count towards the removal of the permit's **expiration date**. A **\$5 fee** is required to issue a duplicate permit with the hunting and targeting shooting restriction removed.
