The County Officers and Civil Service Committee offered the following Local Law for enactment:

STATE OF NEW YORK
COUNTY OF CHENANGO
LOCAL LAW NO 3 OF 1972

LOCAL LAW fixing the annual salary of the Chenango County Treasurer and the annual salary of the Chenango County Attorney.

BE IT ENACTED by the Board of Supervisors of the County of Chenango as follows:

Section 1. The flat annual salary of the County Treasurer of Chenango County shall be \$12,245.00 annually for the balance of the term of office of the present incumbent.

Section 2. The flat annual salary of the County Attorney of Chenango County shall be \$9,500.00 annually for the balance of the term of office of the present incumbent.

Section 3. The above-specified salaries shall be effective January 1, 1973.

Section 4. This law shall be subject to a permissive referendum as provided in Section Twenty-four of the Municipal Home Rule Law of the State of New York, but if no petition for a referendum be filed, then this law shall become effective upon filing same with the Department of State and State Comptroller's Office.
