A LOCAL LAW RELATING TO ELIGIBILITY FOR APPOINTMENT
TO COUNTY OFFICE

Be it enacted by the Board of Supervisors of the County of Chenango as follows:

Section 1. Pursuant to the provisions of the Municipal Home Rule Law, Section 10, subdivision 1 a (1), whenever a vacancy shall occur or exist in any county office, a person otherwise qualified who is a member of the Board of Supervisors, may be appointed to fill the vacancy, provided, he shall have resigned prior to such appointment.


Section 2. This Local Law shall take effect immediately upon the filing of certified copies thereof as required by Section 27 of the Municipal Home Rule Law.

Mr. Eiholzer moved enactment of the foregoing local law, seconded by Mr. Aldrich.
