SECTION 1: Local Law No. 1 of 1956, as amended by Local Law No. 2 of 1959, is hereby amended so as to increase the maximum of the Reserve Fund set forth in Section 11-a of said Self-Insurance Plan from \$50,000.00 to \$200,000.00.
