A Local Law fixing the annual salaries of certain County Officers

Be It Enacted by the Board of Supervisors of the County of Chenango

Section 1. The flat annual salaries of the following named County Officers shall be in the amount set opposite each, to wit:

Commissioner of Social Services	31,600.00
County Superintendent of Highways	22,600.00
Director Planning	27,250.00
Director Data Processing	21,800.00
Director Real Property Tax Service	21,000.00
County Treasurer	20,250.00
Personnel Officer	18,200.00
Commissioner of Elections (2) each	13,250.00

Section 2. The above specified salaries shall be effective on and after January second Nineteen Hundred and Eighty-one.

Section 3. This law shall be subject to a permissive referendum as provided in Section 24 of the Municipal Home Rule Law of the State of New York, but no petition for a referendum be filed, then this law shall become effective upon filing same with the Department of State and State Comptrollers Office
