Section 1. The flat annual salaries of the following named County Officers shall be in the amount set opposite each, to wit:

Commissioner of Social Services	\$34,100.00
County Superintendent of Highways	24,500.00
Director Real Property Tax Service	22,750.00
County Treasurer	21,950.00
Personnel Officer	19,750.00
Commissioner of Elections (2) each	15,100.00

Section 2. The above specified salaries shall be effective on and after January second Nineteen Hundred and Eighty-two.

Section 3. This law shall be subject to a permissive referendum as provided in Section 24 of the Municipal Home Rule Law of the State of New York, but no petition for a referendum be filed, then this law shall become effective upon filing same with the Department of State and State Comptrollers Office.

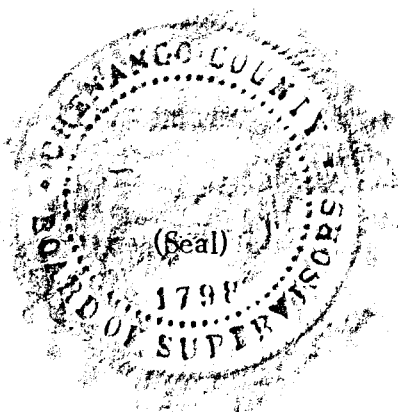
