LOCAL LAW NO. 2 OF 1982

A LOCAL LAW AUTHORIZING THE  
PURCHASE OF THIRD PARTY  
LIABILITY COVERAGE AND FURTHER  
AUTHORIZING THE PAYMENT OF  
RETAINED LIMITS FROM PLAN RESERVE

BE IT ENACTED by the Board of Supervisors of the County of  
Chenango as follows:

SECTION 1: LOCAL LAW NO. 1 OF 1956, as amended by Local Law  
No. 2 of 1959, as amended by Local Law No. 4 of 1978, as amended by Local  
Law No. 2 of 1981, as amended by Local Law No. 3 of 1981, is hereby amended  
by adding thereto, a new section to be designated as Section 11-b following  
Section 11-a as amended to read as follows:

"Section 11-b. Subdivision 1. The Administrator of the  
Plan is hereby authorized, with the approval of the Finance  
Committee (Insurance) of the Board of Supervisors to  
annually contract for the purchase of Excess Employers'  
Liability Insurance (Third Party Liability) in such limits  
as the Finance Committee shall annually approve and  
to include the cost of premiums of said insurance in the  
annual Plan budget.

Subdivision 2. The Administrator of the Plan is also  
authorized to pay from the Contributed Reserve Fund of  
said Plan, or from the amount annually budgeted for benefits  
and awards, if necessary, the retained limit under  
any such insurance coverage purchased for the benefit of  
any participant in the event there is a third party claim  
and recovery resulting in liability of a participant."

SECTION 2: This Local Law shall be effective immediately.
