A local law .. AMENDING THE LOCAL LAW NO. 3 OF 1989 ADOPTED MARCH 20, 1989 ENTITLED "A COUNTY LAW PROTECTING THE HEALTH, SAFETY AND WELL-BEING OF PERSONS IN CHENANGO COUNTY BY PROHIBITING THE DISPOSAL OF RADIOACTIVE WASTE WITHIN THE COUNTY OF CHENANGO."

Mr. Crouch offered the following for adoption:

Section 1. Local Law No. 3 of 1989 adopted by the Board of Supervisors on March 20, 1989 and entitled "A COUNTY LAW PROTECTING THE HEALTH, SAFETY AND WELL-BEING OF PERSONS IN CHENANGO COUNTY BY PROHIBITING THE DISPOSAL OF RADIOACTIVE WASTE WITHIN THE COUNTY OF CHENANGO." is hereby amended at Section 2 thereof to read as follows:

"Section 2. PROHIBIT ACTS.

[No person, corporation, partnership, government agency or instrumentality or other entity shall dispose of or store or cause to be disposed either directly or indirectly any radioactive waste within the geographical boundaries of Chenango County.]

(a) No person, corporation, partnership, government agency or instrumentality or other entity shall dispose of or cause to be disposed either directly or indirectly any radioactive waste within the geographical boundaries of Chenango County.

(b) No person, corporation, partnership, government agency or instrumentality or other entity shall store either directly or indirectly any radioactive waste within the geographical boundaries of Chenango County except when such waste is both (1) generated as a direct result of lawful activities taking place within Chenango County and (2) such storage does not extend beyond six months from the date of generation."

Section 2. This law shall take effect immediately upon proper filing pursuant to law.
