A LOCAL LAW FIXING ANNUAL SALARIES OF CERTAIN COUNTY OFFICERS FOR THE YEAR 1999

BE IT ENACTED, by the Board of Supervisors of Chenango County.

Section 1. The flat annual salaries of the following named County Officers shall be in the amount set opposite each, to wit:

Commissioner of Social Services	\$49,909.00
County Superintendent of Highways	\$57,620.00
Director of Real Property Tax Services	\$43,235.00
Personnel Officer	\$38,795.00
Commissioner of Elections (2) each	\$17,510.00
County Sheriff	\$46,536.00
Clerk of the Board/County Auditor	\$39,761.00
County Attorney	\$72,716.00
County Clerk	\$39,476.00
District Attorney	\$46,733.00

Section 2. The above specified salaries shall be effective on and after January first, Nineteen Hundred and Ninety-Nine.

Section 3. This law shall be subject to a permissive referendum as provided in Section 24 of the Municipal Home Rule Law of the State of New York, but if no petition for a referendum be filed, then this law shall become effective upon filing same with the Department of State.
