A LOCAL LAW FIXING ANNUAL SALARIES OF CERTAIN COUNTY OFFICERS
FOR THE YEAR 2000

BE IT ENACTED, by the Board of Supervisors of Chenango County.

Section 1. The flat annual salaries of the following named County Officers shall be in the amount set opposite each, to wit:

Commissioner of Social Services	\$51,607.00
Director of Public Works	\$61,553.00
Director of Real Property Tax Services	\$28,000.00
Commissioner of Elections (2) each	\$18,035.00
County Clerk	\$40,966.00
County Treasurer	\$47,749.00

Section 2. The above specified salaries shall be effective on and after January first, Two Thousand.

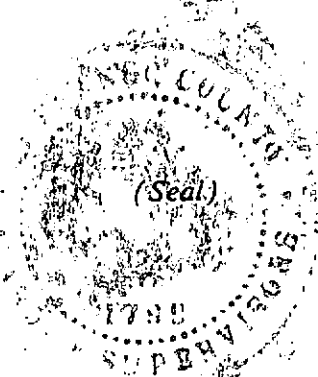
