BE IT ENACTED, by the Board of Supervisors of Chenango County.

Section 1. The flat annual salaries of the following named County Officers shall be in the amount set opposite each, to wit:

County Clerk	\$ 42,485.00
District Attorney	\$ 51,639.00
County Treasurer	\$ 49,404.00
Public Defender	\$ 37,751.00

Section 2. The above specified salaries shall be effective on and after January first, Two Thousand and One.
